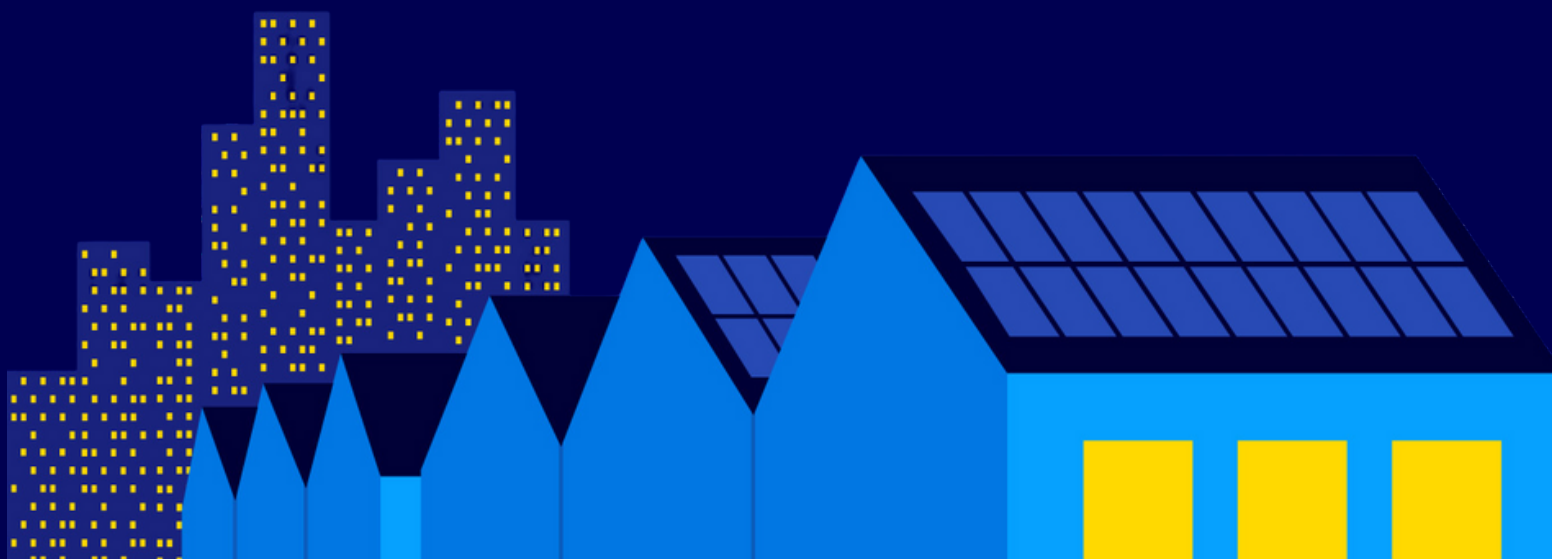

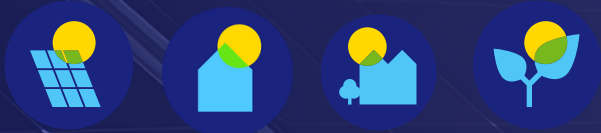

# Utility Scale Working Groups

## **Utility-Scale Commercial**

Bringing together the UK's leading owners and managers of large-scale solar assets, this working group focuses on optimising the commercial development and profitability of UK solar farms.

The group is a hub for knowledge sharing and policy development, engaging directly with external experts and decision makers and discuss a range of topics including regulatory and policy reform, network charging reform, engagement with network operators, asset management best practices, and routes to market for new development.

## **Natural Capital**

This working group brings together expertise from across the industry, as well as wildlife and environmental organisations, to provide support and guidance for members on how to maximise biodiversity and enhance natural capital gain through best practice in land management.

## **Utility-Scale Technical**

This working group brings together organisations from within the utility-scale solar industry focused on large-scale operations, maintenance, and technical asset management to collectively work towards improving standards, developing best practice, and driving innovation in the sector.

The group is a hub for knowledge sharing and policy development, and is particularly focused on innovation, data, digitalisation, research, and optimisation, to enable the industry to drive up plant performance and reduce operational costs.



# Rooftop + Scotland Working Groups

## **Commercial Rooftop Solar**

The Commercial Rooftop working groups, work on bringing together the UK's leading installers and developers of residential and commercial scale rooftop assets.

This working group focuses on optimising commercial development opportunities and reducing barriers to deployment for the rooftop solar market.

## **Solar Energy Scotland**

Solar Energy Scotland works to shape policy that will enable Scotland to fully realise its potential for solar and energy storage applications within the power, heat and transport sectors, in contribution to the nation's ambitious aim of reaching net zero by 2045.

The group focuses on accelerating Scotland's energy transformation by removing key planning barriers, addressing grid constraints, reforming non-domestic rates and more.

## **Residential Rooftop**

The Residential Working Group focuses on all issues relating to residential solar and storage projects' including new build solar. The group focuses on matters related to design, installation, maintenance, and operation.

The group works together to share information and develop policy to ensure a high-quality solar industry in the UK. Its members discuss various topics, including market dynamics and government solar policy initiatives.
