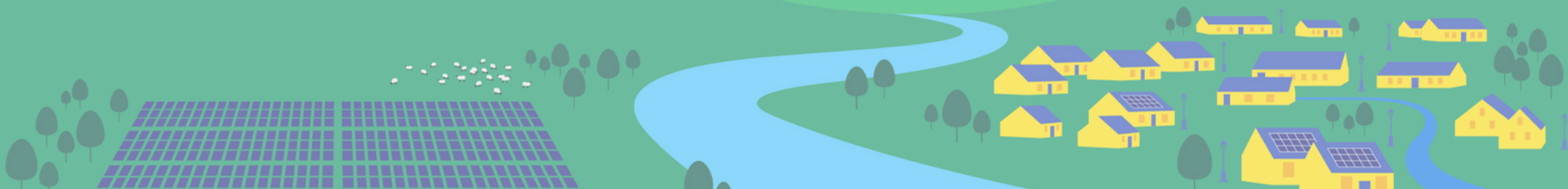

Scotland Working Group

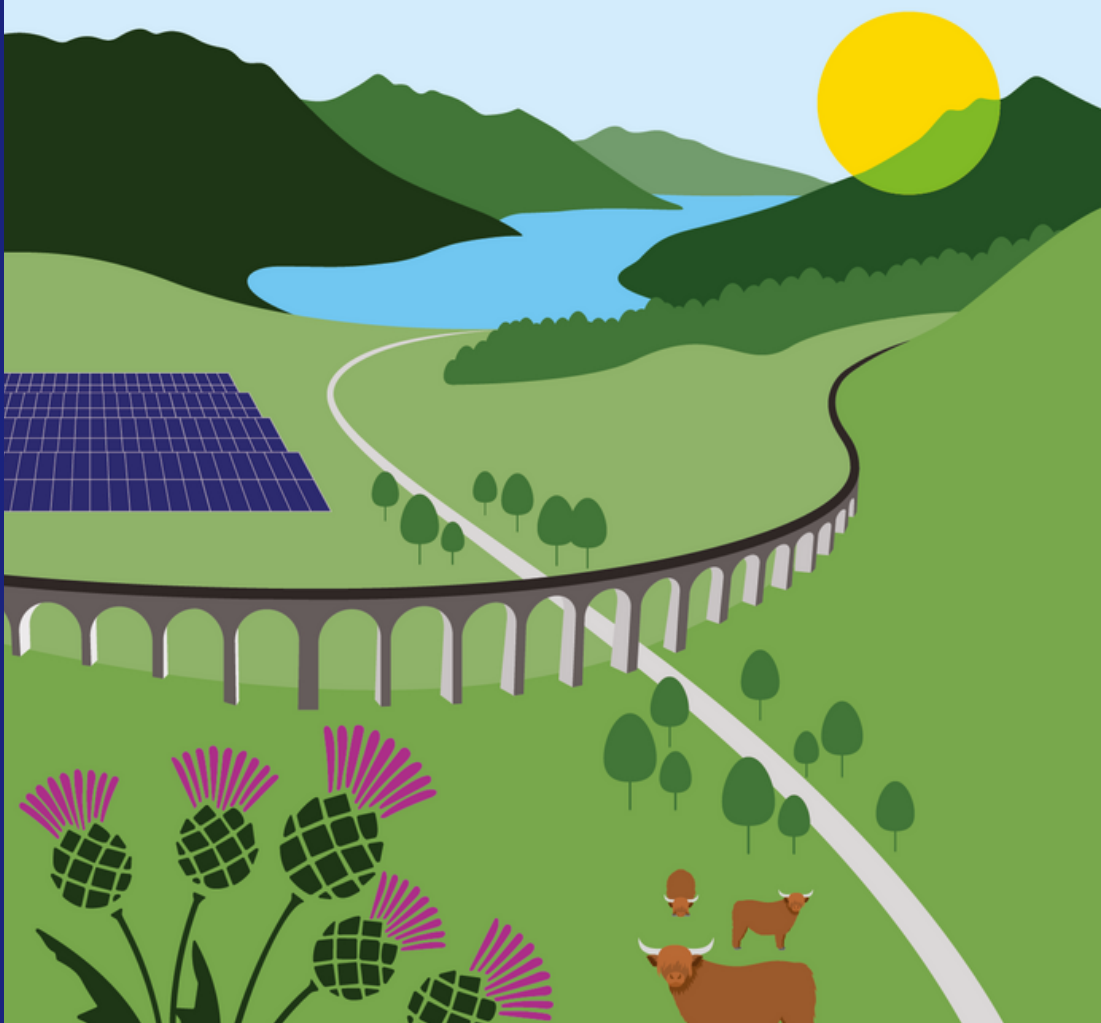


Strengthening policy to unlock Scotland's solar and energy storage potential.

Solar Energy Scotland works to shape policy that will enable Scotland to fully realise its potential for solar and energy storage applications within the power, heat and transport sectors, in contribution to the nation's ambitious aim of reaching net zero by 2045.

The Scotland Working Group focuses on accelerating Scotland's energy transformation by removing key planning barriers, addressing grid constraints, reforming non-domestic rates, targeting the delivery of 4-6GW by 2030.

Solar Energy Scotland hosted a total of 4 working groups in 2024, followed by networking events to foster industry connections.



Steering Groups

These groups enable in-depth discussion and problem-solving on the most pressing issues—harnessing members' specialist knowledge and expertise – to feed back into Working Groups and to influence government policy.

Members can apply to sit in these groups, with each forum having a maximum capacity of 18 members to ensure focused discussion. **Applications are upon open availability.**

Each will meet at least four times a year, face-to-face or virtual, depending on the group's needs.
