Our Forums

Our forums are a hub for collaboration and innovation, where our members come together to tackle pressing challenges, build valuable networks, exchange insights and expertise, and influence government policies. This collective effort is driving the advancement and transformation of the UK solar energy sector.

Utility-Scale Forum



Brings together industry experts to discuss trends, challenges, and best practices in large-scale solar projects, including finance, grid connection, O&M, and policy.

Rooftop Forum



Our Rooftop Forums focus on the residential and commercial rooftop solar market. Topics include installation techniques, financing options, energy storage, and policy incentives.

In 2025 **Solar Energy UK** organised a total of 6 Utility-Scale and Rooftop forums followed by networking events. These initiatives facilitated knowledge sharing, collaboration, and community building within the solar industry.

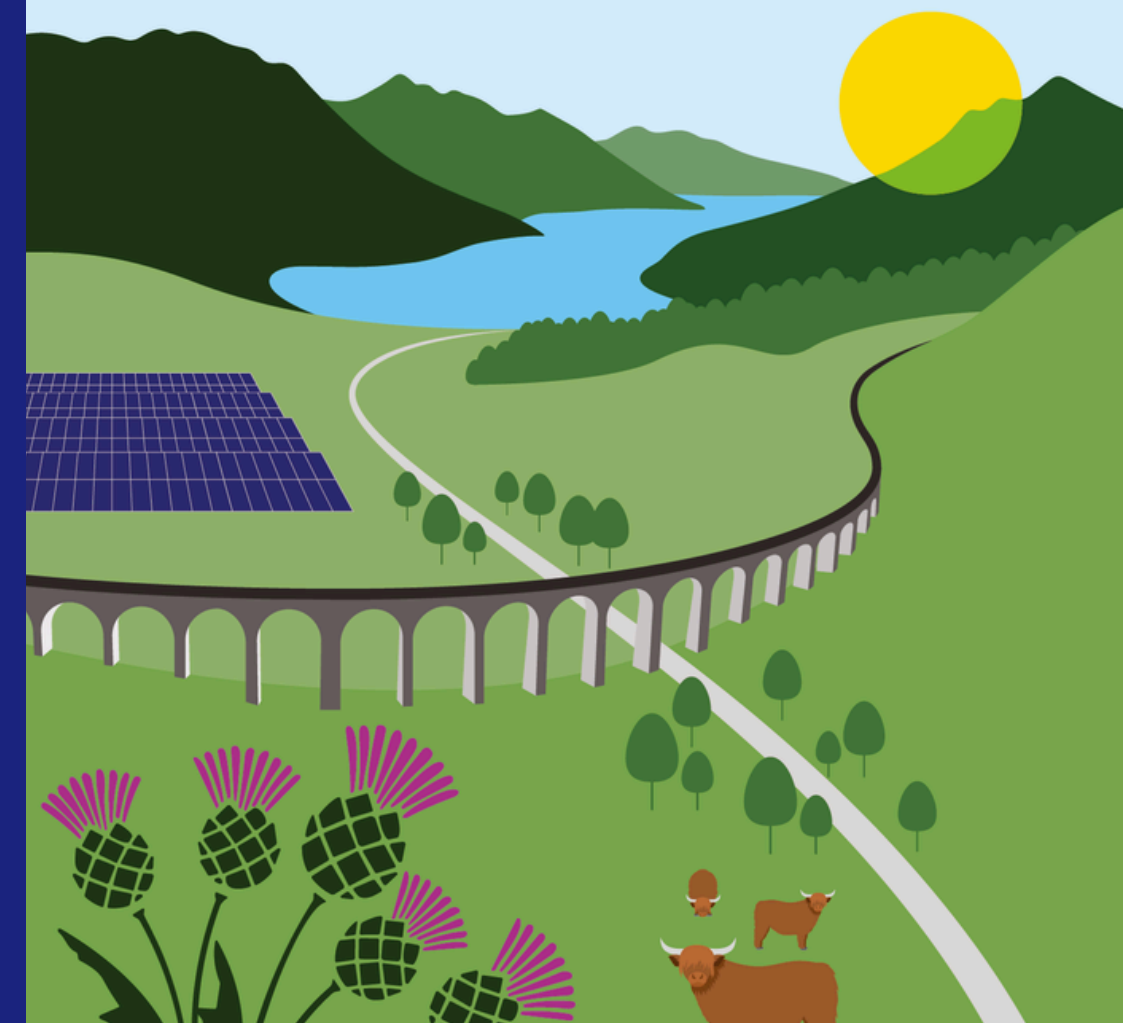

Strengthening policy to unlock Scotland's solar and energy storage potential.

Solar Energy Scotland works to shape policy that will enable Scotland to fully realise its potential for solar and energy storage applications within the power, heat and transport sectors.

The Scotland Forum focuses on accelerating Scotland's energy transformation by removing key planning barriers, addressing grid constraints, reforming non-domestic rates, targeting the delivery of 4-6GW by 2030.

In 2025, Solar Energy Scotland ran 3 forums and delivered "***The Future of Solar & Storage in Scotland***" conference in November, supported by networking events that fostered strong industry connections.



Steering Groups

Our nine Steering Groups enable in-depth discussion and problem-solving on key issues; harnessing members' specialist knowledge and expertise, which is shared in our all-member Forums and used to influence the work of government and wider stakeholders.

These Steering Groups address the following areas:

Each Steering Group has a maximum capacity of 20 members, each with a named attendee and a substitute, to ensure consistent participation and focused discussion over time. Each Steering Group sits for a two-year term, with meetings held at least four times a year, subject to the issues under discussion.

All nine Steering Groups were formed, or re-constituted in 2025, however, places do become available and calls for applications are issued to all members every six months, where places are available. Meetings are held in person or online, depending on the group's needs.
